The Renter agrees to maintain the property and equipment in good condition, and as it was found. The Renter will save and hold Teamworks Dog Training, llc and Michele and Greg Godlevski free and harmless from any and all claims for damages or injury, including death or injury to the person, dog, or property of anyone resulting from or arising out of use of said equipment by the Renter or by the conduct of the Renter's business therein, or any acts by the Renter, his agent, employees, or invitees. The Renter further agrees to provide liability insurance in the minimum amount of \$5000.00 to replace the equipment should it become damaged.

THE FOLLOWING CONDITIONS APPLY TO RENTALS OF TEAMWORKS DOG TRAINING, LLC TIMER EQUIPMENT

- o Electronic Timers are available for rental at \$25 per set (start and finish) per day. Game horns are an additional \$5 per horn per day. Headsets are an additional \$5 per set per day. Game flags are an additional \$5 per set per day.
- o Any damage to the electronic timers will be charged to the club and must be paid in full no later than 30 days following the conclusion of the trial. The price of any damages will be equal to the current replacement cost of the item.
- o **The renter must provide 28 AA batteries for each set of timers and two 9-V batteries for the headset and mini amp.** Changing of batteries to a fresh set prior to the trial is the renter's responsibility. If batteries are provided by Teamworks, the cost is **\$20 per timer set and Teamworks must be notified with this rental form.**
- o Secure and **temperature-controlled storage** of the timers overnight during the trial weekend is the renter's responsibility.
- o The timer control units **MUST NEVER BE ALLOWED TO GET WET OR FREEZE. Units left in the rain or freezing temperatures will be the responsibility of the club to replace at the cost of a brand new unit (about \$450).**
- o Transportation of the timers to the renter's event and back to Teamworks Dog Training is the **renter's responsibility.**
- o Transportation and set up of timers for events being attended by the owner, Michele Godlevski, is complimentary.
- o The owner has the right to deny rentals.
- o Rental applications must be received at least **30 days in advance of the trial day with full payment due before the rental.**
